

## 2021 Student Art Contest by School Specialty

### Official Contest Rules

NO PURCHASE NECESSARY. Participation constitutes participant's ("Participant" or "Teacher Participant") full and unconditional agreement to and acceptance of these Official Contest Rules. Void in Rhode Island. Void where prohibited or restricted by law. Contest is subject to all applicable federal, state and local laws and regulations. The *2021 Student Art Contest by School Specialty* ("Contest") begins at 12:00:00 a.m. Central Time ("CT") on Monday, February 1, 2021 and shall end at 11:59:59 p.m. CT on Friday, December 31, 2021 ("Contest Period"). The Contest is sponsored by School Specialty, Inc., PO Box 1639, Appleton, WI 54912-1639 ("Sponsor"). One (1) winner will be selected by a panel of judges. A total of five (5) winners will be chosen.

**Eligibility:** NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT IMPROVE THE CHANCES OF WINNING. THE CONTEST IS OPEN TO LEGAL RESIDENTS OF THE FORTY-NINE (49) UNITED STATES OTHER THAN RHODE ISLAND, AND THE DISTRICT OF COLUMBIA, who are the age of majority in their state of residence and (i) who are parents or legal guardians of a child between the ages of four (4) and nineteen (19) years of age at the time of entering ("Participant"), or (ii) a school teacher who has obtained the requisite legal consent required to participate from the Participant ("Teacher Participant"). Eligible entries are those created by the Participant's child, or Teacher Participant's student, (either referred to herein as "Entrant"). Employees, officers, directors and other agents and representatives of Sponsor, its affiliates, subsidiaries, sales representatives, retailers, distributors or advertising and promotion agencies ("School Specialty Personnel"), and immediate family members of School Specialty Personnel, are not eligible to participate in the Contest. "Immediate family" means parents, siblings, children and spouse.

**How to Enter:** To enter the Contest, visit [schoolspecialty.com/student-art](http://schoolspecialty.com/student-art) during the Contest Period, complete the *2021 Student Art Contest by School Specialty* entry form and follow all subsequent prompts and instructions to enter the Contest. Participant or Teacher Participant will be required to provide the information requested, including Entrant's first and last name, Participant or Teacher Participants first and last name, e-mail address, city, state, and zip code, school name, original art submission (no reproductions or copies of existing art), and any other information required to complete the entry. A Participant may also nominate a Teacher Participant at time of entry). Entries will be deemed to have been made when they are received and accepted by Sponsor. No other method of entry will be accepted. There is no limit on the amount of submissions made over the duration of the contest, however an Entrant can only win one time. In the event of a dispute regarding the identity of a Contest Participant or Teacher Participant, the authorized account holder of the e-mail address used to submit the entry will be deemed to have made the entry. "Authorized account holder" is defined as the natural person who is assigned to the e-mail address by an Internet access provider, online service provider, or other organization (e.g. business, educational institution, etc.) which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Proof of being the authorized account holder may be required. Entries that are incomplete, illegible, altered or tampered with or not submitted pursuant to these Official Contest Rules are not eligible to win.

School Specialty reserves the right to forgo any chosen artwork within the Contest period in the event no suitable artwork is submitted, however School Specialty will award that month's prize to a previous month's runner-up entry, or subsequent month's runner-up entry, at School Specialty's discretion, so that all prizes will be awarded.

**Selection of Winners & Prize Acceptance:** Sponsor or a company acting under Sponsor's authorization, will form a panel of experts (the "Panel"). Periodically during the contest period, the panel will rank entries from first place to last place, based upon a predetermined rubric. Scoring Criteria:

1. **Execution of Medium:** 50% - The artwork uses the indicated medium in a manner that is understandable and coherent.
2. **Uniqueness of Idea:** 25% - The artwork displays imagination, creativity in a manner above the run of the mill.
3. **Artistry and Skill:** 25% - The artwork demonstrates a mastery of the chosen medium, and has a balance of composition, colors, and details.

The top ranked entry for will be the Winner. Winners will be announced randomly during the year. Winners will be notified by e-mail at the e-mail address submitted with their entry. If the e-mail notification is returned as undeliverable, the entry will be disqualified, the next highest ranked entry will be chosen as the alternate winner. Sponsor is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to deliver the notification to winners.

Once notified, each winner will have forty-eight (48) hours to confirm his/her eligibility with a reply e-mail. If not confirmed, the next highest ranked entry will be chosen as the alternate winner. Sponsor reserves the right to disqualify any winning confirmation if the entry is found to be a copy/reproduction of existing artwork, is fraudulent, or impersonation or cheating behavior is suspected.

**Prizes:** Each Winner will receive one (1) of the following prizes : One (1) merchandise certificate redeemable on Sponsor's online marketplace (schoolspecialty.com) with an approximate retail value ("ARV") of \$250 USD AND if the entry is made by a Teacher Participant or if the Participant has nominated a Teacher Participant on the entry, the Teacher Participant will receive one (1) of the following prizes: One (1) merchandise certificate redeemable on Sponsor's online marketplace (schoolspecialty.com) with an approximate retail value ("ARV") of \$250 USD. The total approximate aggregate value of all the prizes awarded is \$3,000USD. Notwithstanding the forgoing, all prizes will be awarded unless a Participant Entry does not nominate a Teacher Participant on the entry, or the nominated Teacher Participant declines the prize, at such event the Teacher Participant prize for that time period may be awarded at Sponsor's sole discretion. No substitution, return, transfer or cash redemption of any prize will be permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value. **Conditions:** By participating (or in the event of a nominated Teacher Participant, acceptance of a Prize) in the Contest, Participant and/or Teacher Participant agrees to be bound by these Official Contest Rules and the decisions of Sponsor and Panel, which shall be final. Sponsor and the employees, officers, directors, shareholders, agents and representatives of Sponsor, its affiliates, subsidiaries, sales representatives, retailers, distributors, advertising and promotion agencies, and legal advisors are not responsible for and shall not be liable for: (i) any condition caused by events beyond the control of Sponsor that may cause the Contest to be disrupted or corrupted; (ii) any injuries, losses or damages of any kind arising in connection with or as a result of any prize, or acceptance, possession, or use of any prize, or from participation in the Contest; (iii) any printing or typographical errors in any materials associated with the Contest; or (iv) the failure of winner to pay any federal, state and/or local taxes or fees associated with the receipt of any prizes. By participating in the Contest, each Participant and Teacher Participant releases and holds the Sponsor and the employees, officers, directors, shareholders, agents and representatives of Sponsor, its affiliates, subsidiaries, sales representatives, retailers, distributors, advertising and promotion agencies, and legal advisors, harmless from and against any and all losses, damages, rights, claims and actions of any kind in connection with the Contest or resulting from acceptance, possession, use or misuse of any prize, including without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy.
